In recent years there have been significant changes to mental health law and in addition, case law continues to refine the law and thus our practice. These changes, along with the complex interface between the Mental Health Act and Mental Capacity Act, have made it increasingly difficult for practitioners to be confident of their authority for treatment.

This one-day refresher course is accredited by the North of England Approvals Panel (NEAP) as a refresher course for Section 12 approved doctors and is valid for those attending from other parts of England. It will provide an update on statutory changes as well as significant case law and is recommended for all who wish to update their knowledge of mental health law.
