The Mental Health Act 1983 requires that, in those cases where two medical recommendations for the compulsory admission of a mentally disordered person to hospital or for reception into guardianship are required, one of the two must be made by a practitioner approved for that purpose under Section 12(2) of the Mental Health Act 1983. Section 12(2) is also desirable for practitioners providing reports to the Court or giving evidence under Part 111 of the Act.

This course has been accredited by the North of England Approvals Panel (NEAP) for practitioners requiring approval for the first time under Section 12 of the Mental Health Act and is valid for those attending from other parts of England.

Understand current developments in mental health legislation and apply this knowledge practically to your clinical work. This course is designed for doctors who wish to apply for Section 12 approval in England. It is not appropriate for those planning to work as a Section 12 Approved doctor in Wales. Attendance at this course is only one part of the approval process. Please contact your local S12/AC Administrator for full criteria for approval, and how to apply.

THE VENUE

From the M1 -Take junction 43 of M1 onto M621, take junction 3, follow signs for the City Centre for approx. 3/4 miles, the Hotel is on the left.

From the A64/York - Leave the A64 and follow signs for M1, M621 City Centre Past the Royal Armouries on the left, and bear right at T-junction. Past Crown point retail on left, follow sign for City Centre, join the one way system, Hotel is on the left.

From the M62/ Manchester - take junction 27, then on the M621, take junction 3. Follow signs for the city centre for approx. 1/2 mile, hotel is on the left .

From the M62/Hull - Take junction 29, join M1 north. At junction 43 turn onto M621. At junction 3 follow signs for the city centre for 3/4 mile, Hotel is on the left.

Rail - Leeds Train Station, 3 minutes walk from the train station

Parking - The hotel has its own car park and there is an NCP opposite
